- (1) Second Notice of Election and Agenda for the January 9, 2023 meeting.

- (3) Ballot and envelope (Blue). The voting period for the 2023-2024 Election of Board Members is December 9, 2022 through January 9, 2023. There are five vacancies to be filled. <u>Please review the</u> <u>enclosed ballot package and follow the directions listed below for</u> <u>completing and returning the ballot.</u>
- (4) One return white envelope addressed to the Association Secretary.

WHEN MARKING YOUR BALLOT FOLLOW THESE STEP-BY-STEP INSTRUCTIONS

1. Mark ballot (do not vote for more than 5)

2. Place ballot in blue envelope and seal;

3. Place sealed blue envelope inside the pink envelope marked "ballot enclosed" and seal;

4. Sign in the space provided on the face of the pink envelope; and

5. Place the sealed pink envelope in the white envelope addressed to the Forest Lakes Association Office/ Secretary.

6. <u>Return by US mail or by dropping it in the ballot box</u> <u>conveniently located in the club house lobby area on or</u> <u>before the time for tabulating the ballots – 7:00 PM,</u> <u>January 9, 2023.</u>

The newly elected board members will serve a two-year term. The remaining four directors (Cathy Erwin, Jim Harned, Mike Morgan and Cheryl Whitten) will continue to serve their elected/appointed term until January 2025. The area of assignment for each director as well as election of officers will be determined at the time of the organizational meeting for the newly seated Board.
